

STALLS/TRADERS/VENDORS TERMS & CONDITIONS

PAYMENT

Payment must be made by 1st June 201. CASH is the preferred method of payment or either via bank transfer (bank details available on request)

Payment must be made in full; part-payments will not be accepted.

If payment is not received by stipulated dates the stall offer will be automatically withdrawn and the pitch will be reallocated to an alternative trader.

NO REFUNDS will be given once payment is made.

No rebates will be given to traders as a result of bad weather, a change of performance programme or necessary re-siting of stalls. The festival will not accept responsibility for the level of trading during the event.

TRADE

The Licence to trade for Curry Rivel Live 2017 is from 1:00pm Sat 17th June until 11:59pm Sat 17th June 2017. Stall holders should aim to arrive by 10am on the day of the festival and should aim to be ready by 1:00pm (the official gate opening time). There will be no vehicle movement after 12:30pm on the festival site unless cleared with the Safety Officer.

Traders must only sell goods specified in their trade contract and at the prices specified in their application. Traders that do not comply with their trade contract will be closed down.

Sub-contracting or sub-letting a stall or any part of a stall is strictly forbidden.

All food vendors will not be permitted to sale alcohol (this includes brandy coffees, vodka jellies and similar etc.)

The Site Manager & Health and safety officer reserves the right to reallocate or re site stalls.

Entrance for all traders is via Main Gate A.

Unauthorised Curry Rivel Live logos on any goods, i.e. T-shirts, hats, craft goods or disposables will be confiscated.

The sale of bootleg merchandise is prohibited.

Traders must display their trading name on the front of their stall (minimum size A4).

PASSES AND VEHICLES

Traders are responsible for ensuring their staff have the relevant and approved passes. Any traders found without the correct accreditation will be evicted from site.

Vehicle passes are non-transferrable. Any vehicles found to be on-site without the correct passes will be removed.

Traders must co-operate fully with Festival Security in any search of vehicles or stalls if required...

Vehicle movement MUST be kept to a minimum including those with mobile vehicle passes. The onsite speed limit must be observed at all times.

All vehicles brought on-site must be suitably insured.

All vehicles are brought on-site at the risk of the trader. The festival cannot take responsibility for any loss or damage that may occur.

No motorbikes, quad bikes or buggies are allowed on-site.

No animals are allowed on-site (with the exception of guide dogs). Any animal found will be removed and put into kennels. The trader will cover the cost.

SERVICES

Curry Rivel Live can supply electricity/power for the night at an extra charge of £5.

NO GENERATORS are allowed on-site.

Traders who pull more power than they have contractually agreed will be closed down and must cease trading. No refund will be given.

Each food trader must have their own direct water supply.

Communal water standpipes are situated in market areas for access by non-food traders.

Waste water must be put in containers provided. Disposal of waste water directly onto the ground or into ditches is prohibited and will result in the trader being closed down.

WHOLESALE AND PRODUCE

We expect traders to support British Farmers when purchasing their produce.

Fish must be from a certified sustainable source.

No more than one night's supply of bottled gas can be brought on site. Spare gas must be stored in a secure compound (not inside cabins/trailers or vehicles)

HEALTH & SAFETY & License requirements

Your stall is subject to inspection by members of Curry Rivel Lives' own safety team as well as by Local Authority and Fire Brigade officers. Traders must comply with general legislation relating to Health & Safety. This means working safely to build and dismantle the pitch as well as compliance with hygiene and food safety regulations.

A copy of all relevant certification must be sent through when submitting the application form.

Written Food Safety Management Procedures are required by law. These must be available for inspection at all times.

Ensure you prepare properly to construct and dismantle your stall. This means bringing the right tools and properly planning the work. One of the most common failures is not bringing a suitable ladder – please think ahead and ensure any high-level work (such as installing a sign) can be done safely.

All traders must produce a Fire Risk Assessment of their operation, which shall include information on preventing fire and action to be taken if a fire breaks out. You will be required to provide your own extinguishers, signs, training etc if required.

Traders are not permitted to have open fires at the back of the pitches during the event. BBQ's and contained fires may be permitted on agreement.

No Sound systems are allowed on site. Any systems found will be confiscated and the relevant stall may be closed down.

ALL traders must provide proof of Public Liability Insurance if available.

Food traders must be registered with their own Local Authority.

ALL traders must adhere to the Smoke Free legislation..

TRADERS ARE REQUIRED TO COMPLY WITH THE TERMS AND CONDITIONS OF THE SITE LICENCE. If a trader is closed down and/or evicted from site for contravening the Licence, any of the above Terms and Conditions or Environmental Health Standards, they shall not be entitled to any rebate.

PROHIBITED ITEMS

Items not permitted on-site: Glass, body piercing equipment, generators, lasers, sky lanterns, fireworks, nitrous oxide. Products that are deemed 'unfit for human consumption' and used as Legal

Highs (possessed and/or sold as a whole product or separated into smaller quantities) are not permitted.

Weapons or potential weapons are not permitted on-site and will be confiscated and the police will be notified.
